Bank Pensioners' and Retirees' MAHA ABHIYAN – MEGA CAMPAIGN FOR JUSTICE.

Sub: Spirited campaign of the senior and the super senior citizens at the call of CBPRO/AIBPARC continues – Lakhs of emails sent to Hon'ble Prime Minister, Hon'ble Home Minister and Hon'ble Finance Minister of the country – the Affiliates are called upon to ensure that the first phase of the agitation programme ends with an astounding success by making all-time record.

We are standing at the midway of our journey named sending of On-Line Memorandum to the highest authorities of the country narrating the tragic tale of our life and seeking redressal of the same. The response of our members has been exceedingly high. Till today, several lakhs of emails have gone to the decision - making authorities. The campaign started by CBPRO circular 02-2025 dated 21.02.2025. As in other occasions in the past, the campaign generally remains open for 15 days i.e. upto the end of 8th March, 2025 and seeing the overwhelming response of our members, the date might be extended upto the evening of 10th March, 2025.

We have in our hands nearly a week. The General Secretaries of all our affiliates are requested to make a review of the entire situation by taking feedbacks from the ground level. The lower tiers of the organization may be asked to assess the number of persons who have already participated in the campaign. Special stress may be given to the very senior members who are not techno friendly who need help from others to submit the Memorandum On-Line.

We should make it a point that all the Family Pensioners who are also equally affected by the Non-Updation of Pension should join this glorious campaign.

The struggle initiated by CBPRO/AIBPARC is on. When we shall formally declare the closure of the programme of On-Line Memorandum, we shall have to be ready with the preparedness to start the second phase of sending uniform Memorandum to the Members of the Parliament and the subsequent phases will also follow.
