Dear Comrade,

Sub: Meeting with IBA on Residual Issues proposed to be held on 23.04.2025.

Ref: Our earlier letter on the same subject dated April 20, 2025.

Further to the contents of the aforesaid letter written to you, we like to add **the issue of extension of ex-gratia to the Pensioners of the Private Sector Banks and Taken Over Banks**. You are aware of the fact that only one Bank (as far as our knowledge goes) has paid the ex-gratia to the Pensioners. All other Private Sector Banks are yet to implement the advice of IBA in this regard.

We also request you to kindly consider **taking up additionally the issue of Resignees** (for whom you helped getting the option of Pension through a protracted negotiation). To get the full benefit of the same if they are given Additional Five Years advantage as per Pension Regulations 29 for calculation of pension, it will compensate to a Great extent, specially as they are not getting the Benefit of Commutation.

We shall be thankful to you if you could kindly take up the above two issues also with IBA during your meeting.
