Both of them explained in detail the legality of the rationale behind the demand of updation of pension as per provisions already laid down in BEPR (1995). The leaders called upon the members to participate in all future programmes declared by AIBPARC with all seriousness. The Regional Manager of Guwahati RO, Shri Sanjay Kumar, the President of AIBPARC, Assam state unit, Shri M.M. 2. The Triennial Conference of AIBPARC, Assam State Unit started at the same venue at 2 PM and continued for 5 hours. More than 100 delegates from different affiliates of the State attended the conference. **Com. M.M. Baro**, the President of the state committee presided over the meeting. **Com. K.M. Bhattacharyya**, the Secretary of the state unit placed his written report and official resolutions before the house and the Treasurer placed the Accounts for last 3 years. A few delegates participated in deliberations. After the reply of the state secretary, all the papers placed before the house were unanimously accepted.

Com. N.K. Pareek, VP, AIBPARC addressed the house and outlined the struggle initiated by AIBPARC. **Com. S. He requested members not to lose hope but to rely upon the continuous initiatives of AIBPARC in the fields of Judiciary and also in the struggle in the street. The House unanimously elected the following office bearers:

We congratulate all the newly elected Office bearers and do hope that the movement of the Retirees will grow from strength to further strength in this part of the country.
