We have pleasure to convey that a well-attended meeting of Bank Pensioners & Retirees took place at Maheswari College for competitive examinations, Vijayawada on the historic **May Day**. The meeting, presided over by **Com. K.B.G. Tilak**, DGS, AIBPARC, was attended by more than 100 Senior and Super senior citizens belonging to different affiliates of AIBPARC.

The leaders of the movement who had attended the meeting and addressed the gathering included **Com. G.D. Nadaf**, our Advisor, **Com. S. Kuppuswamy**, our Working President, **Com. K. Chandrasekharan** and **Com. K. Suryanarayana Murthy**, both Vice Presidents of AIBPARC and **Com. M.S. Prakash Rao**, All India Treasurer of CBSPARA.

Com. G.D. Nadaf, Advisor, made the following observations:

The BEPR (1995) was based on the patterns of the Pension Rules of Central Government Pensioners and RBI Pensioners. It is a Defined Benefit Pension Scheme and the Corpus is robust. He urged upon the GOI/ IBA to sort out the issue of Pension updation by making an out of Court settlement at an early date. He also demanded immediate resolution of the issue of Special Allowance which is now not being computed for calculation of gratuity and pension.

Com. S. Kuppuswamy, Working President, called upon GOI/ IBA to amend the guidelines for restoration of the commuted value of Pension after 10 years.

Com. K. Chandrashekhara and **Com. K.S. Murthy**, both Vice Presidents, urged upon the necessity of creation of a formal consultative forum at the level of GOI/ IBA so that the Apex level Retiree Organisations in the Banking Industry can talk directly with the decision-making authorities.
