Sub: A delegation of CBPRO meets The Secretary, Department of Financial Services(DFS), Government of India, on 2nd December, 2024



We have pleasure to convey that a patient audience has been given to the delegation and it has been assured that the issues would be looked into in the proper perspective and action taken.


We are hopeful of forward movements in respect of pending issues, particularly Pension Updation.
