Sub: UNI – Group Health Insurance Policy [EoL] of All India UCO Bank Pensioners' Federation with United India Insurance Company Limited. [Period of the Policy 5th June, 2023 to 4th June, 2024. POLICY NO. 0304002823P106059124]

With reference to above we like to bring before you following most important facts for your necessary consideration and doing the needful without any delay:

1. You are aware that our 142 members across the country who have renewed IBA Group Medical Policy 2022-23 were allowed to renew the subject UNI-Group Health Insurance Policy offered by United India Insurance Company Ltd.
2. For renewal of the subject Policy threshold limit [under Bank's Group Mediclaim Policy] was prescribed by your Office as under:
Rs.3,4,5,6 lacs. / Rs.7, Rs.8 lacs/ Rs.9 lacs
Accordingly premium for renewal of the Policy was fixed on sum insured Rs.3 lacs, Rs. 5 lacs, Rs.7 lacs.
3. Accordingly willing members paid premium and renewed the subject Policy.
4. But this year 2023-24 havoc change in IBA Group Medical Policy for Bank Retirees has taken place. Base Policy with various caps have been introduced and the premium amount of Base Policy, Top Up Policy have gone up exorbitantly.
5. Bank Retirees have been pushed to such a helpless condition, most of them will not be able to continue to renew the Policy with the same sum insured amount which they did last year 2022-23.
6. **Our query is if they fail to renew the same threshold limit under IBA Group Medical Policy 2023-24 as prescribed by your Office, how they will be included in your Subject Policy? Will there be any limitation for them? Will they have to pay some more premium to be in touch with the Subject UNI – Group Health Insurance Policy? Or anything else?**

We would request you to immediately take up the matter with your Head Office for quick direction to our 142 members under the subject UNI Policy so that they can decide at
